There was a discussion on the 10 year rule for personal protection gear. Because this is a complicated topic I am referring to Fire District Affairs bulletin June 2014-July 2014.

This bulletin has a concise guide on rules for replacement of pep.

The Firefighter 1 classes will increase to 104 hours starting in January.

The burn building is up and running. The ribbon cutting was on 8/11/14.

At a cost of \$1.6 million it is state of the art.

Facilities are 1710 square feet on 3 stories.

There will also be 2 county inspectors at drills.
